

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.linked.insure and Linked Insurance Advisors, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Linked Insurance Advisors, LLC include www.linked.insure. The Linked Insurance Advisors, LLC website is a Insurance Agency site. By using the Linked Insurance Advisors, LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Linked Insurance Advisors, LLC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Linked Insurance Advisors, LLC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
